• Initiatives/meetings

- 1. During the week of July 10th, I attend the 4-H camp held at the Fayette County park, we had around 111 campers attend.
- 2. On July 17th myself and two other volunteers installed a Little Free Library at Meadow Bridge Elementary where people can pick up free books and leave books for others to enjoy. Once the Meadow Bridge school is complete, we'll move the library to a permanent location in front of the new school
- 3. On July 19th I attended the Healthy Villages kickoff event at the Smithers Gateway center, where a group called Dynamis Advisors Inc. will assist the Town of Smithers and the City of Montgomery to re-envision and repurpose buildings and areas. They will be looking for stakeholder interviews on what the community wants to see for the areas.

4. On July 22nd I attended the Roll and Read event put on by Parents as Teachers at the NRHA Oak Hill location where we had 13 Families comprising of 22 – Adults and 24 - Children

• I submitted our 4th and final Quarterly Program report to the State FRN office

- 30% of activities promote Alcohol, Tobacco and Drug Prevention and Intervention
- 30% of activities promote Child and Family Safety Prevention and Intervention
- 20% of activities promote Economic and Poverty Prevention and Intervention effort
 - Reported 39 events for April, May and June
 - o 13 were categorized as Alcohol, Tobacco and Drug Prevention (33%)
 - 14 were categorized as Child and Family Safety Prevention and Intervention (35%)
 - 12 were categorized as Economic and Poverty Prevention and Intervention (30%)

• Teen Court

- We took 10 youth volunteers to an escape room on Tuesday for their volunteer appreciation event
- I'll be attending open houses at Fayetteville PK-8, Oak Hill Middle School and Midland Trail High School to recruit youth volunteers for the upcoming year
- We are hosting a mock trial on Monday, August 28th at 5pm at the Courthouse Annex building. This mock trial is open to the public, anyone can attend to see how a teen court hearing works. Youth volunteers do not have the complete the application to attend this mock trial.
- In September we'll be back to meeting on the 4th Monday of every month
- If you know a youth grade 7th through 12th that would like to volunteer, we are always accepting applications. the online application is here: https://forms.gle/ZGgZPeciUjMXBFwE8
- The FRN received a grant from the Greater Kanawha Valley Foundation to provide basic needs items. These items can include beds, dressers, clothing, and household items. The referral form needs to be completed by a direct service provider, not the individual needing the items. 4 members of the FRN Board review all the referrals. The grant is of \$25,000 and will end December 31, 2023 or when funds run out, https://forms.gle/R6syBhyt8YKFcmvZ8
 - We've received 58 referrals to date and we have fulfilled 45 referrals with 1 still pending review from the FRN Board
- As always, I send weekly update emails every Monday for the information I receive the week prior. These updates include funding or grant opportunities as well. And if you ever want information included in these updates please let me know or if any events are coming up. Any time sensitive information will be sent through a normal email to the listserv which currently has 229 people.

PRESENTATION:

- Foster Grandparents Program Amanda Moore
 - Available to those 55 and older to mentor at risk children, inside the classroom, daycare, or another non-profit/child focused organization. Volunteers are consistent throughout the year
 - $\circ~$ Our program has funding for 99 grandparents, women and men
 - We do have an MOU with the Fayette County Board of Education to put volunteers into the public schools
 - Volunteers work anywhere from 15-40 hours a week, they receive a stipend of \$4 an hour, which will not affect any income/benefits they receive
 - Volunteers for this program must be low or fixed income
 - Volunteers must pass a background check and go through training, which takes about 2 weeks
 - $\circ~$ We are looking to stations (ie schools) and volunteers, if you know of anyone, please let us know and we'll work with them
